In 2021 our transportation provided 12,105 trips to 412 unique individuals and Chore and Homemaker services provided 959 units of service to 91 unique individuals.

Resource Navigation Program - connects people to information, tools, and services that promote aging with independence and dignity. 2021 results included more than information and referral calls handled during the year.
